Those are available for purchase, at a minimal cost, with your registration kit. Bounties will require one of the following: no required decals, standard decals, or standard plus windshield banner.

Photo and Video Standards

It is expected that photos and videos submitted be of reasonable size and quality. We're not looking for studio-level stuff (although bonuses for such material may exist), but photos and video should be in focus and greater than 1200px wide. Photos and videos submitted as part of a claim will be used on our website and in our advertising, so submit content that you'll be proud to have hundreds of thousands of people seeing.
